This application is an electronic follow-up request for special temporary authority for a 30-day period to provide temporary-fixed Ku-band services using an earth station technically identical to the earth station authorized under call sign E040270. The FCC granted the initial application on September 4, 2005. The application request authority that is identical to that requested by the applicant in connection with a prior earth station STA application (File No. SES-STA-20050908-01224). The authority requested herein will permit the provision of communications services in areas affected by Hurricane Katrina.
