12. Description

ORBIMAGE seeks special temporary authorization to operate this earth station to communicate with three Indian-licensed satellites on certain specified frequencies, for which ORBIMAGE currently has authority to communicate using a different earth station that is collocated with this earth station but which has been rendered temporarily inoperable due to severe weather in Oklahoma.
