## **12. Description**

SES Americom, Inc. ('SES') hereby requests extension of Special Temporary Authority ('STA') SES-STA-20070529-00727 to communicate with up to 300 earth stations on vessels ('ESV's') via the NewCom International earth station E040267 in Miami, Florida. STA extension is sought for a period of one hundred and eighty days pending action on SES's earth station application for an ESV license, call sign E060335 (FCC File No. SES-LIC-20060824-01502). All operations will be consistent with the services proposed in the E060335 application.
