In support of this request, Vizada hereby incorporates by reference the information provided in its applications for regular BGAN service authority as amended, its prior STA requests, and its pleadings in those proceedings. Vizada agrees to continue to operate subject to the terms and conditions contained in the original STA grant.

Grant of this STA is in the public interest because it will assure continuity of service for Vizada's many customers who are currently receiving BGAN service via the Immarsat 4F3 satellite.
