Vizada, Inc. ("Vizada") requests a grant of special temporary authority to allow the earth stations with call sign E000284 to continue communicating with the Inmarsat 3F4 satellite at 54° W.L. This request is a renewal of Vizada's pending STA, which has not been acted upon yet by the Commission (File No. SES-STA-20090622-00775).

Grant of this STA is in the public interest because it will ensure continuity of service for Vizada's many customers. Moreover, grant of this STA will not cause interference to any other L-band operator and will not prejudice any interested party.
