## **12. Description**

SES Americom, Inc. requests extension of special temporary authority (FCC File No. SES-STA-20100219-00229) to permit earth station E980076 to continue to communicate with the NSS-5 spacecraft in the conventional C-band in order to provide telemetry, tracking and control for the spacecraft pending grant of SES WORLD SKIES' petition for declaratory ruling to add the conventional C-band payload on the NSS-5 satellite to the Permitted Space Station List at 20.0 W. L. (FCC File No. SAT-PPL-20091208-00142). STA extension is requested for 30 days.
