On August 6, 2010, Allen Holdings, Inc. d/b/a Allen Communications ("Allen") filed an application for license for a new satellite earth station at Kapolei, Hawaii (E100091/File No. SES-LIC-20100809-01023), which requested standard C-band and Ku-band frequencies, as well as extended C-band frequencies. Allen also filed a "prior use" STA request to commence operation of E100091 to provide service to the U.S. Navy (SES-STA-20100809-01022), which was granted August 23, 2010, for standard C-band frequencies. Allen hereby clarifies that its above-referenced STA extension request, filed on October 19, 2010, is also only to use the standard C-band frequencies and not the extended C-band frequencies.
