12. Description

GUSA Licensee LLC is applying for special temporary authority to operate the earth station antenna in Sebring, Fl, to support the launch campaign of the second generation replacement Globalstar satellites. The earth station antenna in Sebring will be used to communicate with the current Globalstar satellites (Call sign S2115) and the replacement satellites Globalstar 2.0. Globalstar has filed three separate applications for special temporary authority — one for each antenna at the Sebring, Fl location. Globalstar requests that they be processed simultaneously. Multiple earth station antennas provide opportunities for telemetry and control of multiple satellites in view simultaneously at a ground location, which is a common occurrence for a LEO satellite constellation.
