12. Description

STA request to transmit prior to grant of license request. The proposed licensee of the uplink is Florida State University, which is also licensee of Station WFSU-FM, Tallahassee, Florida. This uplink is needed to distribute important noncommercial educational programming by Station WFSU-FM. That FM station is a key part of FSU's service to the State Capital and to area public radio listeners. The uplink is needed to make that broad programming distribution by WFSU-FM possible. Frequency coordination is underway for this antenna and a formal license request will be filed upon completion of the Coordination on or after 2-21-11.
