SES Americom, Inc. is granted extension of Special Temporary Authority (STA) for 60 days beginning 2/25/2012 to permit earth station E970336 to communicate with the Ciel 2 spacecraft in order to provide telemetry, tracking and control in the 17.3-17.8 GHz uplink and 12.2-12.7 downlink frequencies of the Ciel 2 space station at 128.85 WL under the following conditions:

1. In accordance with 47 C.F.R. § 25.202 (g), telemetry, tracking and telecommand functions for U.S. domestic satellites shall be conducted at either or both edges of the allocated band(s). Frequencies, polarization and coding shall be selected to minimize interference into other satellite networks and within their own satellite system.
2. Operations are restricted to parameters defined in SES-MFS-20111011-01205.
3. All operations shall be on an unprotected and non-harmful interference basis and shall not claim protection from, interference caused to it by any other lawfully operating station.
4. SES Americom, Inc. shall immediately cease operations upon notification of harmful interference. Complaints of all radio interference shall be forwarded immediately to the Commission in writing.
5. Any action taken or expense incurred as a result of operations pursuant to this special temporary authority is solely at SES Americom, Inc's own risk.
