Gogo LLC (Gogo) respectfully requests special temporary authority for a period of 180 days beginning December 10, 2012, to operate 30 technically identical Ku-band transmit/receive earth stations for the provision of Aeronautical Mobile Satellite Service (AMSS) on domestic and international flights. Gogo also seeks authority to perform continued ground-based testing of four AMSS terminals. Authority is sought pending action on Gogo's application as amended for a blanket license for AMSS terminals under Call Sign E120106.
