SES Americom, Inc. ('SES') requests a further 30-day extension of the special temporary authority it was granted in File No. SES-STA-20120917-00826 to permit earth station E970336 to communicate with the foreign-licensed QuetzSat-1 spacecraft. A request for extension of that STA was previously filed on Oct. 17, 2012, and remains pending (File No. SES-STA-20121017-00937). The earth station will continue to be used to perform tracking, telemetry and command functions for the spacecraft at 61.5 W.L. SES incorporates by reference the supporting materials that were submitted in File No. SES-STA-20120917-00826.
