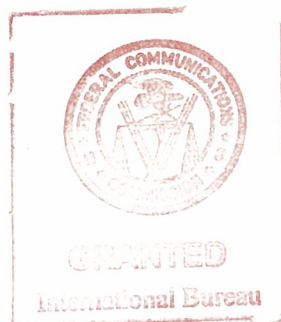

Special Temporary Authority (STA)

Sure Shot Transmissions, Inc. (Sure Shot Transmissions) is granted STA, under special conditions, for 60 days to operate its fixed earth station, Call Sign E940167, in the 14.0-14.5 GHz (Earth-to-space) and 11.7-12.2 GHz (space-to-Earth) frequency bands with the replacement 1.5 meter antenna subject to the conditions set forth below.

- 1) All operations under this grant of STA shall be on an unprotected and non-harmful interference basis. Sure Shot Transmissions shall not cause harmful interference to, and shall not claim protection from interference caused to it by, any other lawfully operating radio communication system.
- 2) In the event of any harmful interference as a result of operations under this grant of special temporary authority, Sure Shot Transmissions shall cease operations immediately upon notification of such interference and shall immediately inform the Commission, in writing, of such an event.
- 3) Grant of this STA is without prejudice to any determination that the Commission may make regarding the pending application SES-MOD-20130510-00391 nor is it of a continuing nature. Future STA requests must document rationale of existence of extraordinary circumstances requiring temporary operations in the public interest and that delay in the institution of these temporary operations would seriously prejudice the public interest. See 47 C.F.R. 25.120(b)(1).
- 4) This grant was authorized under Section 1.62 of the Commission's rules, 47 C.F.R. § 1.62.
