

SES Americom, Inc.(SES) is grant STA under the following conditions for 30 days for earth station Call Sign E000102 at Bristow, Virginia to use transmit frequencies: 14.0 GHz, 14.499 GHz and receive frequencies: 11.701 GHz, 11.7005 GHz, 12.1995 GHz to perform telemetry, tracking, and control ("TT&C") operations for SES-6 satellite, Call Sign S2870, during in-orbit testing (IOT) at 26° W.L. to its permanent orbital location 40.5° W.L.

1. Operations under this STA are subject to this STA's application Narrative, and subject to terms, conditions, and technical specifications set forth in SES' spending application SAT-PPL-20120717-00117.
2. All operations under this grant of STA shall be on an unprotected and non-harmful interference basis. SES shall not cause harmful interference to, and shall not claim protection from interference caused to it by, any other lawfully operating radio communication system.
