### **Request for Special Temporary Authority**

Televisa, S.A de C.V., a Mexican corporation and an applicant for FCC authority to license two temporary fixed Earth stations as filed with the FCC today (Forms 312 attached), pursuant to Sections 74.433 and 1.931 of the Commission's Rules, hereby requests Special Temporary Authority for a period of 180 days to operate each of said stations (TVSA-Mob 1 and TVSA-Mob 2) in the following limited circumstances and others to be identified in coming months<sup>1</sup>:
