12. Description

Harris Corporation is requesting an extension of Special Temporary Authority, for a sixty day period, to operate a 3.8 meter C band earth station in connection with a critical project for the Federal Aviation Administration (FAA). The attached letter from the FAA demonstrates that Harris is the current FAA Telecommunications Infrastructure contractor. This STA is necessary as it will enable the provision of critical flight path information to the FAA, as the subject earth station provides air traffic radar services to the FAA. Harris submits that a grant of this application will serve the public interest because it will assist the FAA's mission of ensuring flight safety. Harris has filed a corrected permanent license request for these facilities (see Submission ID No. IB2013001891, attached) however this application remains pending.
