12. Description

SES respectfully requests an expedited STA to use the 9M antenna on E000152 to perform TT&C only with NSS-806 during relocation of the satellite from 40.5W to 47.5W and to maintain the satellite at 47.5W. The FCC has previously granted an STA for a 9.3m antenna at the same teleport to perform such TT&C operations. File No. SES-STA-20130722-00649 (granted August 29, 2013). The TT&C frequencies and the maximum EIRP and EIRP density during drift and on-station at 47.5W will be the same as under the previously granted STA. Grant of this STA is in the public interest as it will facilitate safe operation of NSS-806. All operations will be performed on a non-interference, non-protected basis, and on the same terms as the previously granted STA.
