ORBCOMM License Corp(ORBCOMM), is granted, under the following conditions, Special Temporary Authority (STA) for 60 days to operate a 50 kHz uplink channel to the ORBCOMM (S2103) NGSO satellite system in the 150-150.05 MHz MSS frequency band.

Conditions:

1. Operations under this authority are on a non-interference basis only.
2. Operations under this authority are on a non-protected basis only.
3. Operations under this authority are limited to the parameters identified in the pending underlying application.
4. In the event that there is a report of interference, ORBCOMM must immediately terminate transmissions and notify the FCC in writing.
4. Any action taken or expense incurred as a result of operations pursuant to this special temporary authority is solely at ORBCOMM risk.
5. Grant of this authorization is without prejudice to any future FCC action pending applications.

Application of ORBCOMM License Corp. for Special Temporary Authorization

ORBCOMM Ocilla, GA Gateway Earth Station FCC Call Sign E940536

Pursuant to Section 25.120(b)(3) of the Commission's Rules, ORBCOMM License Corp. ("ORBCOMM") respectfully requests a 60-day Special Temporary Authorization ("STA") for the ORBCOMM Gateway Earth Station located at Ocilla, GA (FCC Call Sign E940536) (the "GES") to operate an additional 50 kHz feeder uplink channel centered at 150.025 MHz for communication with all satellites in the ORBCOMM satellite constellation authorized under FCC Call Sign S2103. The parameters of operation for the additional STA uplink channel will be identical to the currently authorized GES feeder uplink channel at 149.61 MHz.

ORBCOMM requests the STA to allow for use of the additional uplink channel until processing and grant of ORBCOMM's pending application to modify the regular authorization for the GES to add the new 150.025 MHz uplink channel is completed.¹ Issuance of the requested STA will serve the public interest, convenience, and necessity by allowing use of the new uplink channel for the earliest possible implementation of required increases in throughput capacity and coverage for ORBCOMM satellite constellation feeder link communications.
