Special Temporary Authority (STA)

SES Americom, Inc. is granted extension of STA that was previously granted under IBFS SES-STA-20140319-00152 for 60 days, starting June 16, 2014, for fixed earth station Call Sign E930289 in Somis, California, to communicate with INTELSAT 18 satellite at orbital location 180° E.L in the 5925- 6425 MHz (Earth-to-space) and the 3700- 4200 MHz (space-to-Earth) frequency bands, and NSS-9 satellite at orbital location 177° W.L. orbital location in the 5850- 6425MHz (Earth-to-space) and the 3625-4200 MHz (space-to- Earth) frequency bands under the following conditions:

1. Operations under this authority are on a non-interference basis only.
2. Operations under this authority are on a non-protected basis only.
3. In the event that there is a report of interference, SES Americom, Inc. must immediately terminate transmissions and notify the FCC in writing.
4. Any action taken or expense incurred as a result of operations pursuant to this special temporary authority is solely at SES Americom, Inc.'s own risk.
5. Grant of this authorization is without prejudice to any determination that the Commission may make regarding pending application IBFS File No. SES-MFS-20140114-00021.
6. Operation is granted without prejudice to any future FCC enforcement action against SES Americom, Inc. in connection with any unauthorized operation of radio facilities.
