Intelsat License LLC herein requests an additional 30 days, from September 19, 2015 through October 18, 2015, of the Special Temporary Authority previously granted Intelsat to use its Hagerstown, Maryland C-band earth station, call sign KA275, to provide launch and early orbit phase services for Intelsat 34, telemetry, tracking, and command during in-orbit testing at 51.5 W.L, and TT&C during the drift of Intelsat 34 to its final location at 55.5 W.L. Additionally, Intelsat is requesting authority to provide TT&C to Intelsat 34 on-station at 55.5 W.L.
