Intelsat License LLC herein requests an additional 30 days, from October 18, 2015 through November 16, 2015, of the Special Temporary Authority previously granted Intelsat to use its Fillmore, California C-band earth station, call sign E4132, to provide launch and early orbit phase services for Intelsat 34, telemetry, tracking, and command during in-orbit testing at 51.5 W.L., TT&C during the drift of Intelsat 34, and TT&C at the final location of the satellite at 55.5 W.L. Specifically, Intelsat is seeking an extension of STA to continue to conduct TT&C for Intelsat 34 at 55.5 W.L. Intelsat 34 arrived on-station at 55.5 W.L. on October 2, 2015.
