Special Temporary Authority (STA)

Intelsat License, LLC is granted a STA extension from SES-STA-20151014-00683, for 60 days, from November 17, 2015 to January 17, 2016, to continue to conduct telemetry, tracking and control operations ("TT&C") to Intelsat 34 satellite (Call Sign S2915) at orbital location 55.5° W.L. via its earth station E000363 at Fillmore, California at 34° 24' 18.0" NL/118° 53' 39.0" WL under the following conditions

1. Uplink (Earth-to-space) frequency to Intelsat 34 satellite are 6173.70 MHz and 6176.30 MHz (LHCP) center frequency within coordinated emission and power limits.
2. Downlink (space-to-Earth) frequencies from Intelsat 34 satellite are 3949 MHz, 3949.50 MHz, 3950.50 MHz, and 3951 MHz (RHCP) center frequencies.
- 3 Operations, shall not cause harmful interference to, and shall not claim protection from, interference caused to it by any other lawfully operating station and it shall cease transmission(s) immediately upon notice of such interference.
4. In the event of any harmful interference as a result of operations under this grant of STA, Intelsat shall cease operations immediately upon notification of such interference and shall immediately inform the Commission, in writing, of such an event.
5. Grant of this authorization is without prejudice to any determination that the Commission may make regarding pending or future Intelsat License, LLC's applications.
6. Any action taken or expense incurred as a result of operations pursuant to this STA is solely at Intelsat License, LLC's risk.
7. This action is issued pursuant to Section 0.261 of the Commission's rules on delegated authority, 47 C.F.R. §0.261, and is effective immediately.

Intelsat License LLC (“Intelsat”) herein requests an additional 60 days—from November 17, 2015 through January 15, 2016—of the Special Temporary Authority (“STA”)<sup>1</sup> previously granted<sup>2</sup> Intelsat to use its Fillmore, California C-band earth station—call sign E000363—to provide on-station, telemetry, tracking, and command (“TT&C”) service to Intelsat 34 (S2915) at its permanent location of 55.5° W.L.<sup>3</sup> Intelsat has filed a pending application to permanently modify its E000363 license to include TT&C operations for Intelsat 34.<sup>4</sup>

The Intelsat 34 operations will be performed using the following frequencies:

6173.7 MHz and 6176.3 MHz in the uplink (LHCP); and  
3949.0 MHz, 3949.5 MHz, 3950.5 MHz, and 3951 MHz in the downlink (RHCP).

In further support of this request, Intelsat incorporates by reference Exhibit A, which contains technical information that demonstrates that the operation of the earth station will be compatible with its electromagnetic environment and will not cause harmful interference into any lawfully operating terrestrial facility, and the waiver request submitted with its original STA request. In the extremely unlikely event that harmful interference should occur due to transmissions to or from its earth station, Intelsat will take all reasonable steps to eliminate the interference. Intelsat also notes that it is seeking to continue to operate in the frequencies listed in this request at power levels not to exceed 32.2 dBW.
