Intelsat License LLC herein requests an additional 30 days, beginning February 13, 2016, of Special Temporary Authority previously granted Intelsat, to use its Castle Rock, Colorado Ku-band earth station, call sign KL92, to provide launch and early orbit phase services for the SES-9 satellite. As a result of a launch delay, SES-9 is now scheduled to be launched no earlier than February 22, 2016. Intelsat expects the LEOP period to last between fourteen and eighty days.
