DPII Holdings, LLC, is granted a Special Temporary Authority (STA), for 30 days, beginning April 12, 2016, to operate four .73 meter (QCT90) Ku-band antennas at various locations to communicate with Galaxy 18 satellite (S2733) at the orbital location 123° W.L. to transmit/receive in the 14000-14500 MHz (Earth-to-space) and 11700-12200 MHz (space-to-Earth) frequency bands, under the following conditions:

1. Operations under this authority are on a non-interference basis only.
2. Operations under this authority are on a non-protected basis only.
3. In the event of any harmful interference under this grant of STA, DPII Holdings, LLC, must cease operations immediately upon notification of such interference, and must inform the Commission, in writing, immediately of such an event.
4. Grant of this STA is without prejudice to any determination that the Commission may make regarding pending or future DPII Holdings, LLC applications.
5. Any action taken or expense incurred as a result of operations pursuant to this STA is solely at DPII Holdings, LLC's risk.
6. This grant is issued pursuant to Section 0.261 of the Commission's rules on delegated authority, 47 C.F.R. § 0.261, and is effective upon release.

The application was dismissed without prejudice.
