## **12. Description**

Intelsat License LLC herein requests a grant of Special Temporary Authority for 60 days, commencing June 6, 2016, to use its Castle Rock, Colorado Ku-band earth station, call sign E030096, to provide telemetry, tracking, and command services to Intelsat 31 during in-orbit testing at 76.5 W.L; and during the drift of Intelsat 31 to and at its final location of 95.05 W. L. Intelsat 31 is expected to be launched on May 28, 2016.
