Special Temporary Authority

SES Government Solutions ("SES-GS") is granted extension of special temporary authority (STA) for 60 days beginning October 26, 2016 to operate a fixed earth station with two 2.4 meter antennas in Pago Pago, American Samoa with the O3b United Kingdom licensed non-geostationary Ka-band satellite system (Call Sign S2935) in the 28.601-28.817 GHz (Earth-to-space) and 18.801-19.017 GHz (space-to-Earth) frequency bands on the following conditions:

1. In the event of any harmful interference as a result of operations under this grant of STA, SES-GS shall cease operations immediately upon notification of such interference and shall immediately inform the Commission, in writing, of such an event.
2. All operations shall be on an unprotected, non-interference basis to both government and non-government operations.
3. Any action taken or expense uncured as a result of operations pursuant to this STA is solely at SES-GS's own risk.
4. Grant of this authorization is without prejudice to any determination that the Commission may make regarding pending application SES-LIC-20160714-00658/SES-AMD-20160926-00799 or future SES-GS applications.

This action is issued pursuant to Section 0.261 of the Commission's rules on delegated authority, 47 C.F.R § 0.261 and is effective immediately.

SES Government Solutions (SES-GS) seeks a further 60 day extension of the special temporary authority it was granted in File Nos. SES-STA-20160426-00372, SES-STA-20160624-00604, and SES-STA-20160823-00737 to operate an earth station with two 2.4 meter antennas in Pago Pago, American Samoa, with the O3b U.K.-licensed non-geostationary Ka-band satellite system (call sign S2935). Extension of the STA is sought pending action on an application for a permanent license at this location, File No. SES-LIC-20160714-00658, as amended in File No. SES-AMD-20160926-00799. SES-GS incorporates by reference the supporting information that was submitted with File No. SES-STA-20160426-00372.
