Special Temporary Authority (STA)

Intelsat License LLC is granted a STA extension from SES-STA-20170313-00261, for 30 days, beginning May 21, 2017, to operate its C-band earth station, call sign E040125, in Riverside, California to provide launch and early orbit phase (LEOP) services for the GSAT-9 satellite licensed by India, using the following center frequencies: 6415.00 MHz and 6423.496 MHz (RHCP) (Earth-to-space) and 4194.00 MHz and 4197.504 MHz (LHCP) (space-to-Earth) under the following conditions;

1. All operations must be within the coordinated emission and power limits.
2. The LEOP operations must be coordinated with all operators of satellites that use the same frequency bands and are in the LEOP path. All operators of satellites in that path will be provided with an emergency phone number where the licensee can be reached in the event that harmful interference occurs. Currently the 24x7 contact information for the GSAT-9 satellite LEOP mission is as follows: Ph.: (703) 559-7701 -East Coast Operations Center (primary); (310) 525-5591- West Coast Operations Center (back-up). 3. All operations shall be on an unprotected and non-harmful interference basis, Intelsat License LLC, E040125, shall not cause harmful interference to, and shall not claim protection from interference caused to it by any other lawfully operating station and it shall cease transmission(s) immediately upon notice of such interference.
4. Grant of this authorization is without prejudice to any determination that the Commission may make regarding pending or future Intelsat License LLC applications.
5. This STA can only be used to provide launch and early orbit phase ("LEOP") services for the GSAT-9 satellite.
6. This action is issued pursuant to Section 0.261 of the Commission's rules on delegated authority, 47 C.F.R. §0.261, and is effective immediately.

Dear Ms. Dortch:

Intelsat License LLC (“Intelsat”) herein requests an additional 30 days of Special Temporary Authority (“STA”)¹ previously granted Intelsat to use its Riverside, California C-band earth station—call sign E040125—to provide launch and early orbit phase (“LEOP”) services for the GSAT-9 satellite.² GSAT-9 is now expected to be launched on May 5, 2017.³ The LEOP period is expected to last approximately 10 days.⁴

The GSAT-9 LEOP operations will be performed at the following frequencies: 6415.00 MHz and 6423.496 MHz in the uplink (RHCP), and 4194.0 MHz and 4197.504 MHz in the downlink (LHCP). The LEOP operations will be coordinated with all operators of satellites that use the same frequencies and are in the LEOP path.⁵ All operators of satellites in that path will be provided with an emergency phone number where the licensee can be reached in the event that harmful interference occurs.

In further support of this further extension request, Intelsat incorporates by reference Exhibits A and B, which contain technical information that demonstrates that the operation of the earth station will be compatible with its electromagnetic environment and will not cause harmful interference into any lawfully operating terrestrial facility, as well as a waiver request. In the extremely unlikely event that harmful interference should occur due to transmissions to or from its earth station, Intelsat will take all reasonable steps to eliminate the interference.

Finally, Intelsat clarifies that during the GSAT-9 LEOP mission, ISRO will serve as the mission manager. ISRO will build and send the commands to the Intelsat antenna, which will process and execute the commands. Telemetry received by Intelsat will be forwarded to ISRO. Intelsat will perform the ranging sessions by sending a tone to the spacecraft periodically. Intelsat will remain in control of the baseband unit, RF equipment, and antenna.

Grant of this STA request will allow Intelsat to help launch the GSAT-9 satellite and thereby promotes the public interest.
