## **12. Description**

The Alaska ground station shall be used to assist the Swedish Space Corporation (SSC) with the TT&C support of the Deimos-2 spacecraft as its ownership is transitioned from Spain to Canada. Support is expected to consist of one NGS0 pass each day as backup for a TBD duration commencing on or about May 22, 2017 while ground station licensing is being processed in Canada.
