Special Temporary Authority

Alaska Communications Internet, LLC, is granted special temporary authority for 60 days, beginning November 21, 2017, to operate a C-band network consisting of two 3.8-meter and one 2.4-meter antennas in Anchorage, AK and at St. Paul Island, AK to operate over with the Eutelsat 115WB satellite at the 114.9 ° W.L. orbital location in the 5929-6001 MHz (Earth-to-space) and 3704-3776 MHz (space-to-Earth) frequency bands under the following conditions:

1. Operations under this authority are on a non-interference basis only.
2. Operations under this authority are on a non-protected basis only.
3. In the event of any harmful interference under this grant of special temporary authority, Alaska Communications Internet, LLC, must cease operations immediately upon notification of such interference, and must inform the Commission, in writing, immediately of such an event.
4. Any action taken or expense incurred as a result of operations pursuant to this special temporary authority is solely 'at Alaska Communications Internet, LLC's risk.
5. Grant of this authorization is without prejudice to any determination that the Commission may make regarding pending or future Alaska Communications Internet, LLC's applications.
