Intelsat License LLC ("Intelsat") is granted special temporary authority (STA) for 30 days, beginning December 04, 2017, to operate its Hagerstown, MD fixed earth station to communicate with Intelsat 34 (S2915) at the 55.5° W.L. orbital location in the 5925 – 6425 MHz (Earth-to-space) and 3700 – 4200 MHz (space-to-Earth) frequency bands under the following conditions:

1. Operations will not exceed the operational power levels and parameters requested and coordinated.
2. Operations shall not cause harmful interference to, and shall not claim protection from, interference caused to it by any other lawfully operating station and it shall cease transmission(s) immediately upon notice of such interference.
3. Grant of STA is without prejudice to any determination that the Commission may make regarding any Intelsat's future applications.
4. Transmitters(s) must be turned off during antenna maintenance to ensure compliance with the FCC-specified safety guidelines for human exposure to radiofrequency radiation in the region between the antenna feed and the reflector. Appropriate measure must also be taken to restrict access to another regions in which the earth station's power flux density levels exceed the specified guidelines.
5. Any action taken or expense incurred as a result of operations pursuant to this STA is solely at Intelsat's risk.
6. Operations during the period November 29, 2017 to the date of this grant were authorized pursuant to Section 1.62 of the Commission's rules 47 C.F.R. § 1.62.

This grant is issued pursuant to Section 0.261 of the Commission's rules on delegated authority, 47 C.F.R. § 0.261, and is effective upon release.

Dear Ms. Dortch:

Intelsat License LLC (“Intelsat”) herein requests an additional 30 days of Special Temporary Authority (“STA”)¹ previously granted Intelsat to utilize a 9m C-band antenna located at its Hagerstown, Maryland teleport to communicate with Intelsat 34 (S2915) to provide services to a new customer.²

Intelsat will continue to perform operations in the following frequencies: 3700 – 4200 MHz and 5925 – 6425 MHz.

In further support of this request, Intelsat incorporates by reference Exhibits A and B from its original request,³ which contain technical information that demonstrates that the operation of the earth station will be compatible with its electromagnetic environment and will not cause harmful interference into any lawfully operating terrestrial facility, as well as a radiation hazard analysis report. In the extremely unlikely event that harmful interference should occur due to transmissions to or from its earth station, Intelsat will take all reasonable steps to eliminate the interference.

Grant of this STA extension request will allow Intelsat to continue providing customer services and thereby promotes the public interest.


