SIS Live Ltd is granted special temporary authority (STA) for 30 days, beginning April 16, 2018, to operate its Temporary-Fixed Earth Station located in TX, to provide events coverage of MotoGP Austin Flyaway using the Galaxy 3C (S2381) satellite at the 95.05 W.L. orbital location transmitting in the 14.2465 -14.2645 GHz (Earth-to-space) frequency bands under the following conditions:

1. Operations shall not cause harmful interference to or claim protection from other lawfully operating stations and it shall cease transmission(s) immediately upon notice of such interference.
2. Operations will not exceed the operational power levels and parameters requested.
3. In the event of any harmful interference as a result of operations under this grant of STA, SIS Live Ltd. shall cease operations immediately upon notification of such interference and shall immediately inform the Commission, in writing, of such an event.
4. Transmitter(s) must be turned off during antenna maintenance to ensure compliance with the FCC-specified safety guidelines for human exposure to radiofrequency radiation in the region between the antenna feed and the reflector. Appropriate measure must also be taken to restrict access to other regions in which the earth station's power flux density levels exceed the specified guidelines.
5. Any action taken or expense incurred as a result of operations pursuant to this STA is solely at SIS Live Ltd risk.
6. Grant of this authorization is without prejudice to any determination that the Commission may make regarding pending or future SIS Live Ltd. applications.

This grant is issued pursuant to Section 0.261 of the Commission's rules on delegated authority, 47 C.F.R. § 0.261, and is effective upon release.
