Pacific Dataport Inc. is granted STA to operate remote terminals of its Fixed Satellite Service ("FSS") VSAT network (Call Sign E180097) for 60 days to communicate with the SES-15 (Call Sign 2951) satellite at orbital location 129.15° W on 14000.0-14500 MHz (Earth-to-space) and 11700-12200 MHz (space-to-Earth) frequency bands under the following conditions:

1. Operations will be in accordance with and will not exceed the proposed parameters presented in its pending application FCC IBFS File No.: SES-LIC-20180410-00345.
2. Operations of the proposed remote terminals: 1.2m, 1.8m, and 2.4 m antennas are remotely controlled by SES Americom's hub stations Call Signs: E160021, E160022, and E160015.
3. All operations shall be on an unprotected and non-harmful interference basis, Pacific Dataport Inc., E180097, shall not cause harmful interference to, and shall not claim protection from, interference caused to it by any other lawfully operating station and it shall cease transmission(s) immediately upon notice of such interference and must inform the Commission, in writing, immediately of such an event.
4. The licensee shall, at all times, take all necessary measures to ensure that operation of this (these) authorized earth station(s) does not create potential exposure of humans to radiofrequency radiation in excess of the FCC exposure limits defined in 47 CFR §§ 1.1307(b) and 1.1310. Physical measures must be taken to ensure compliance with limits for both occupational/controlled exposure and for general population/uncontrolled exposure, as defined in these rule sections. Compliance can be accomplished in most cases by appropriate restrictions, such as fencing. Requirements for restrictions can be determined by predictions based on calculations, modeling, or by field measurements. The FCC's OET Bulletin 65 (available on-line at [www.fcc.gov/oet/rfsafety](http://www.fcc.gov/oet/rfsafety)) provides information on predicting exposure levels and on methods for ensuring compliance, including the use of warning and alerting signs and protective equipment for workers.
5. Grant of this authorization is without prejudice to any determination that the Commission may make regarding pending FCC IBFS File No.: SES-LIC-20180410-00345 or future Pacific Dataport Inc.'s applications.
6. Any action taken or expense incurred as a result of operations pursuant to this STA is solely at Pacific Dataport Inc.'s risk.
7. Grant of this authorization is without prejudice to any future FCC enforcement action in connection with any unauthorized operation of radio facilities.
