> Re: Request for Special Temporary Authority Mountainside, Maryland Earth Station E140121

Dear Ms. Dortch:

Intelsat License LLC ("Intelsat") herein requests 180 days of Special Temporary Authority ("STA"),<sup>1</sup> commencing upon grant, to use its Mountainside, Maryland Ku-band earth station—call sign E140121—to provide telemetry, tracking, and command ("TT&C") services for Intelsat 9 (Call Sign S2380) during its drift from 29.5° W.L. to 66.15° E.L.<sup>2</sup> The drift is expected to begin May 20, 2018 and take approximately eight months.

TT&C operations will be performed in the following frequencies: 14.0005 GHz and 14.4945 GHz in the uplink; and 11.7005 GHz and 11.702 GHz in the downlink. The drift operations will be coordinated with all operators of satellites that use the same frequency bands and are in the drift path.<sup>3</sup> All operators of satellites in that path will be provided with an emergency phone number where the licensee can be reached in the event that harmful interference occurs. In the extremely unlikely event that harmful interference should occur due to transmissions to or from its earth station, Intelsat will take all reasonable steps to eliminate the interference.
