Intelsat License LLC (“Intelsat”) herein requests an additional 30 days of Special Temporary Authority (“STA”)¹ previously granted Intelsat to continue using its Fillmore, California C-band earth station—call sign KA391—to provide telemetry, tracking, and command (“TT&C”) services² to Intelsat 805 at its permanent location of 169.0° E.L.³ Intelsat has a pending application to permanently modify its KA391 license to support Intelsat 805 TT&C services at 169.0° E.L.⁴

The Intelsat 805 TT&C operations will continue to be performed at the following frequencies: 6173.7 MHz and 6176.3 MHz (CP) in the uplink, and 3947.5 MHz, 3948.0 MHz, 3952.0 MHz, and 3952.5 MHz (RHCP) in the downlink.

Intelsat incorporates by reference the technical materials included in its permanent application.⁵ In the extremely unlikely event that harmful interference should occur due to transmissions to or from its earth station, Intelsat will take all reasonable steps to eliminate the interference.

Special Temporary Authority (STA)

Intelsat License LLC- is granted a special temporary authority for 30 days, beginning July 20, 2018 to operate its C-band earth station in Fillmore, California to provide telemetry, tracking, and command (TT&C) services to Intelsat 805 (call sign S2404) at its permanent location of 169.0° E.L., using the following center frequencies: 6173.70 MHz and 6176.30 MHz (Earth-to-space), and 3947.50 MHz, 3948 M Hz, 3952 MHz, and 3952.50 MHz (space-to-Earth), under the following conditions:

1. All operators of satellites will be provided with an emergency phone number where the licensee can be reached in the event that harmful interference occurs, currently the 24x7 contact information for the Intelsat 903 is as follows: Phone: (703) 559-7701 - East Coast Operations Center (primary); (310) 525-5591 - West Coast Operations Center (back-up). Request to speak with Harry Burnham or Kevin Bell.
2. All operations under this grant of special temporary authority shall be on an unprotected and non-harmful interference basis. Intelsat 's KA391 shall not cause harmful interference to, and shall not claim protection from interference caused to it by, any other lawfully operating radio communication system.
3. In the event of any harmful interference under this grant of special temporary authority, Intelsat License LLC KA391, must cease operations immediately upon notification of such interference and must inform the Commission, in writing, immediately of such an event.
4. Grant of this authorization is without prejudice to any determination that the Commission may make regarding pending or future Intelsat License LLC applications.
5. Any action taken or expense incurred as a result of operations pursuant to this special temporary authority is solely at Intelsat License LLC-s risk.
6. This grant is issued pursuant to Section 0.261 of the Commission's rules on delegated authority, 47 C.F.R. § 0.261.
