Intelsat License LLC herein requests a grant of Special Temporary Authority for 30 days, commencing September 18, 2018, to use its Riverside, California Ku-band earth station, call sign E060384, to provide launch and early orbit phase services for the Azerspace-2 satellite. Azerspace-2 is expected to launch on September 18, 2018. Intelsat expects the LEOP period to last approximately 180 days.
