1. Operations with the 9.2 m Satcom model 920CS with total maximum eirp for all carriers of 84.24 dBW.
2. Operations under this authority are on a non-interference basis only.
3. Operations under this authority are on a non-protected basis only.
4. In the event that there is a report of interference, Westar Satellite Services LP must immediately terminate transmissions and notify the FCC in writing.
