Hawaii Pacific Teleport, L.P. ("HPT"), - is granted a special temporary authority for 60 days, beginning September 21, 2018, to utilize its earth station in kapolei, Honolulu in support communications with EUTELSAT 133WA (S3031) at the 132.85 W.L. orbital location for testing and validating services necessary for operations. Testing will be performed in the following frequency bands: 14.0-14.5 GHz (Earth-to-space) and 10.95 - 11.2 GHz, and 11.45-11.7 GHz (space-to-Earth), under the following conditions:

1. Operations under this authority are on a non-interference basis only.
2. Operations under this authority are on a non-protected basis only.
3. All operations under this grant of special temporary authority shall be on an unprotected and non-harmful interference basis. Hawaii Pacific Teleport, LP (E010236), shall not cause harmful interference to, and shall not claim protection from interference caused to it by, any other lawfully operating radio communication system.
4. In the event of any harmful interference under this grant of special temporary authority, Hawaii Pacific Teleport, LP, must cease operations immediately upon notification of such interference, and must inform the Commission, in writing, immediately of such an event.
5. Any action taken or expense incurred as a result of operations pursuant to this special temporary authority is solely at Hawaii Pacific Teleport's risk.
6. Grant of this authorization is without prejudice to any determination that the Commission may make regarding pending or future at Hawaii Pacific Teleport's applications.
7. This action is issued pursuant to Section 0.261 of the Commission's rules on delegated authority, 47 C.F.R. §0.261, and is effective immediately.
