Westar Satellite Services LP is granted Special Temporary Authority to operate its fixed earth station located in Cedar Hill, TX for 60 days on frequency bands 14000-14500 MHz (Earth-to-space) and 11700-12200 MHz (space-to-Earth) with the AMC-15 satellite (Call Sign 2180) at the 105.05° W orbital location under the following conditions:

1. Operations with the 7m SATCOM, model 700 KS, antenna at geographical coordinates 32°34'42"N, 96°58'56"W (NAD-83), emission designator 36M0G1F, eirp 71.00 dBW., eirp density 44 dBW/4kHz.
2. Operations under this authority are on a non-interference basis only.
3. Operations under this authority are on a non-protected basis only.
4. In the event that there is a report of interference, Westar Satellite Services LP must immediately terminate transmissions and notify the FCC in writing.


