

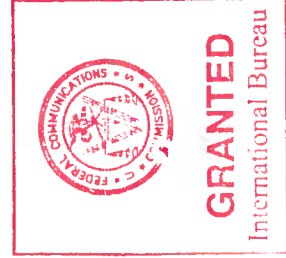

EchoStar Operating L.L.C. ("EchoStar") is granted a special temporary authority for 60 days, starting June 18, 2019, to operate its earth station in Cheyenne, WY, to provide telemetry, tracking, and command ("TT&C") for the EchoStar 23 satellite during the satellite's drift from its current location at 44.9° W.L. to the 72.6° W.L. orbital location. Operations are limited to frequency bands 17.3-17.310, 17.791 GHz (Earth-to-space) and 12.20-12.21GHz (space-to-Earth) under the following conditions:

- 1 Operations will not exceed the operational power levels and parameters coordinated.
2. All operations under this grant of special temporary authority shall be on an unprotected and non-harmful interference basis. EchoStar shall not cause harmful interference to, and shall not claim protection from interference caused to it by, any other lawfully operating radio communication system.
3. In the event of any harmful interference under this grant of special temporary authority, EchoStar must cease operations immediately upon notification of such interference, and must inform the Commission, in writing, immediately of such an event.
4. All operators of satellites will be provided with an emergency phone number where the licensee can be reached in the event that harmful interference occurs, Currently the 24x7 contact information for the EchoStar satellite is Ph.: (307) -633-5225. Ask for Silas Cole.
5. EchoStar Operating L.L.C. must apply for market access via an earth or space station license request. This authorization does grant authority for market access in the US.
6. Any action taken or expense incurred as a result of operations pursuant to this special temporary authority is solely at EchoStar's risk.
7. Grant of this authorization is without prejudice to any determination that the Commission may make regarding pending or future EchoStar's applications.

This action is issued pursuant to Section 0.261 of the Commission's rules on delegated authority, 47 C.F.R. §0.261, and is effective immediately.

ATTACHMENT 1

Request for Extension of Special Temporary Authorization

EchoStar Operating L.L.C. (together with its affiliates, “EchoStar”) requests a 60-day extension from June 18, 2019 to August 17, 2019 of its previously granted applications for special temporary authority.¹ EchoStar will continue to operate the five earth stations in Cheyenne, WY, Blackhawk/Summerset, SD, and Gilbert, AZ (Call Signs E980005, E020248, E150098, E070014, and E170094) for telemetry, tracking, and command and feeder link communications with the EchoStar 23 satellite during its relocation from 44.9° W.L. to, and operations at, the 72.6° W.L. orbital location.

The operating parameters of the earth stations are set forth in the underlying modification applications to add the EchoStar satellite at 72.6 W.L. as a point of communications for TT&C and feeder links.² The requested modification will allow regular operations of EchoStar 23 at 72.6° W.L. for service to DISH subscribers in the United States and Canada. EchoStar is in the process of securing Canadian authorization for its operations at the proposed orbital location and expects to commence the drift to 72.6° W.L. on June 15, 2019.

Grant of the requested STA will serve the public interest by allowing EchoStar the flexibility to manage its satellite fleet efficiently, provide for more productive use of its satellites, and further ensure full use of spectrum and uninterrupted service from the nominal 72.6° W.L. orbital location. Indeed, the Commission has a longstanding policy of leaving fleet management decisions to satellite operators because doing so generally serves the public interest.
