Special Temporary Authority ("STA")

Intelsat License LLC is granted STA for 60 days at geographic coordinates 33° 39' 52.8" N/084° 16' 12.0" W (NAD-83) in Ellenwood, Georgia to provide telemetry, tracking, and command ("TT&C") services for the Galaxy 11 (Call Sign S2253) satellite On-Station at permanent orbital location 93.1° W. Operations will be under the following conditions:

1. Operations are on center frequencies: 14000.5 MHz and 14498.5 MHz (Earth-to-space) and 11701.0 MHz and 11702.0 MHz (space-to-Earth).
2. Operations will not exceed coordination agreements as requested in the STA application.
3. All operations shall be on an unprotected and non-harmful interference basis, Intelsat License LLC, E170122, shall not cause harmful interference to, and shall not claim protection from, interference caused to it by any other lawfully operating station and it shall cease transmission(s) immediately upon notice of such interference and must inform the Commission, in writing, immediately of such an event.
4. All operators of satellites in that path will be provided with an emergency phone number where the licensee can be reached when harmful interference occurs. 5. Grant of this STA is without prejudice to any determination that the Commission may make regarding pending FCC IBFS File No. SES-MFS-20190509-00575 or future Intelsat License LLC applications.
6. Any action taken or expense incurred as a result of operations pursuant to this STA is solely at Intelsat License LLC's risk.

Dear Ms. Dortch:

Intelsat License LLC (“Intelsat”) herein requests a grant of Special Temporary Authority (“STA”)¹ for 60 days, commencing July 24, 2019, to use its Ellenwood, Georgia Ku-band earth station (Call Sign E170122) to provide telemetry, tracking, and command (“TT&C”) services for Galaxy 11 (Call Sign S2253) at its permanent location of 93.1° W.L.² The satellite is currently drifting to 93.1° W.L. and is expected to arrive on-station no earlier than July 24, 2019. Intelsat has a pending modification application for this antenna to add Galaxy 11 as a point of communication.³

The proposed TT&C operations will be performed using the following frequencies: 14000.5 MHz and 14498.5 MHz in the uplink; and 11701.0 MHz and 11702.0 MHz in the downlink. The proposed operations at 93.1° W.L. will be consistent with Intelsat’s coordination agreements for the location.

In further support of this request, Intelsat incorporates by reference the technical information found in its pending application.⁴ In the extremely unlikely event that harmful interference should occur due to
