Special Temporary Authority ("STA")

Alascom, Inc ("Alascom") is granted Special Temporary Authority for 60 days beginning January 07, 2020 to operate its fixed earth station located in Ouzinkie, AK with Spaceway 1 satellite (Call Sign S2191) at orbital location 138.9°W on center frequencies of 29500-30000 MHz (Earth-to-space) and 19700-20200 MHz (space-to-Earth) under the following conditions:

1. Operations under this authority are on a non-interference basis only.
2. Operations under this authority are on a non-protected basis only.
3. Operations shall not exceed parameters proposed in the pending application IBFS file number SES-MOD-20191122-01572.
4. Alascom shall, at all times, take all necessary measures to ensure that operation of this earth station does not create potential exposure of humans to radiofrequency radiation in excess of the FCC exposure limits defined in 47 CFR § 1.1307(b) and 1.1310. Physical measures must be taken to ensure compliance with limits for both occupational/controlled exposure and for general population/uncontrolled exposure, as defined in these rule sections. Compliance can be accomplished in most cases by appropriate restrictions, such as fencing. Requirements for restrictions can be determined by predictions based on calculations, modeling, or by field measurements. The FCC's OET Bulletin 65 (available on-line at www.fcc.gov/oet/rfsafety) provides information on predicting exposure levels and on methods for ensuring compliance, including the use of warning and alerting signs and protective equipment for workers.
5. In the event of any harmful interference under this grant of special temporary authority Alascom must cease operations immediately upon notification of such interference, and must inform the Commission in writing, immediately of such an event.
6. Any action taken or expense incurred as a result of operations pursuant to this special temporary authority is solely at Alascom's risk.
7. Grant of this authorization is without prejudice to any determination that the Commission may make regarding Alascom's pending IBFS file number SES-MOD-20191122-01572 or future Alascom applications.

This action is issued pursuant to Section 0.261 of the Commission's rules on delegated authority, 47 CFR § 0.261, and is effective immediately.
