Intelsat License LLC ("Intelsat") is granted STA for 60 days beginning March 04, 2020 at geographic coordinates 39° 35' 54" N/077° 45' 33" W (NAD-83) in Hagerstown, MD to provide telemetry, tracking, and command ("TT&C") services for the Galaxy 11 (Call Sign S2253) satellite On-Station at permanent orbital location 93.1° W.L. Operations will be under the following conditions:

1. Operations are on center frequencies: 14000.5 MHz and 14498.5 MHz (Earth-to-space) and 11701.0 MHz and 11702.0 MHz (space-to-Earth).
2. Operations will not exceed coordination agreements as requested in the STA application.
3. All operations shall be on an unprotected and non-harmful interference basis, Intelsat, shall not cause harmful interference to, and shall not claim protection from, interference caused to it by any other lawfully operating station and it shall cease transmission(s) immediately upon notice of such interference and must inform the Commission, in writing, immediately of such an event.
4. All operators of satellites in that path will be provided with an emergency phone number where the licensee can be reached when harmful interference occurs. Currently the 24x7 contact information for the Galaxy 11 On-Station mission is as follows: Ph.: (703) 559-7701 - East Coast Operations Center (primary); (310) 525-5591 - West Coast Operations Center (back-up). 5. Grant of this STA is without prejudice to any determination that the Commission may make regarding pending or future Intelsat applications.
6. Any action taken or expense incurred as a result of operations pursuant to this STA is solely at Intelsat License LLC's risk.
7. Operations of this station during the period from expiration of February 18, 2020, to the grant of this special temporary authority was authorized pursuant to Section 1.62 of the Commission's rules, 47 C.F.R. §1.62.

This action is issued pursuant to Section 0.261 of the Commission's rules on delegated authority, 47 C.F.R. §0.261, and is effective upon release.

Intelsat License LLC (“Intelsat”) herein requests an additional 60 days of Special Temporary Authority (“STA”)<sup>1</sup> previously granted to Intelsat<sup>2</sup> to use its Hagerstown, Maryland Ku-band earth station (Call Sign KA258) to provide telemetry, tracking, and command (“TT&C”) services for Galaxy 11 (Call Sign S2253) at its permanent location of 93.1° W.L.<sup>3</sup> Intelsat has a pending license application for this antenna to add Galaxy 11 as a point of communication.<sup>4</sup>

The Galaxy 11 TT&C operations will continue to be performed using the following frequencies: 14000.5 MHz and 14498.5 MHz in the uplink; and 11701.0 MHz and 11702.0 MHz in the downlink. The operations at 93.1° W.L. will be consistent with Intelsat’s coordination agreements for the location.
