Re: Section 1.65 Notification of Change to the Ownership and Control of Speedcast Communications, Inc.

Dear Ms. Dortch:

Speedcast Communications, Inc. (“SCI”), by its attorneys, submits this letter pursuant to Section 1.65 of the rules of the Federal Communications Commission (“FCC”).¹

On April 23, 2020, Speedcast International Limited—the ultimate parent of SCI—and thirty-two (32) of its subsidiaries, including SCI, each commenced a voluntary case under chapter 11 of the Bankruptcy Code in the United States Bankruptcy Court for the Southern District of Texas (Case No. 20-32243 (MI)) (the “Chapter 11 Cases”).² On May 4, 2020, in connection with the Chapter 11 Cases, Speedcast Americas, Inc. and its wholly-owned subsidiaries holding FCC licenses or authorizations, including SCI, filed for *pro forma* assignment and transfer of control of those licenses to their respective debtors, as debtors-in-possession.³

SCI has three pending applications before the FCC at the time the assignment and transfer of control was filed, including modifications to call signs E030170 and E910609, as well as a request for special temporary authority for call sign E090176.⁴ This letter updates the aforementioned pending applications.
