Special Temporary Authority (“STA”)

Intelsat License LL, as debtor-in-possession is granted extension of STA, for 30 days, to operate its fixed-satellite C-band earth station located in Riverside, California to provide launch and early orbit phase (“LEOP”) services for the MEV-2 satellite (Call Sign S3059). MEV-2 was launched on August 15, 2020. The final location for MEV-2 will be 1.0° W. The MEV-2 LEOP operations will be performed at the following frequencies: 5924.0 MHz, 5925.2 MHz, 6170.0 MHz, 6180.0 MHz, and 6424.0 MHz (Earth-to-space); and 3701.0 MHz, 3944.5 MHz, 3955.5 MHz, and 4199.8 MHz (space-to-Earth) under the following conditions:

1. Operations, shall not cause harmful interference to, and shall not claim protection from, interference caused to it by any other lawfully operating station and it shall cease transmission(s) immediately upon notice of such interference.
2. In the event of any harmful interference under this grant of STA, Intelsat License LLC, as debtor-in-possession must cease operations immediately upon notification of such interference, and must inform the Commission, in writing, immediately of such an event.
3. The LEOP operations must be coordinated with all operators of satellites that use the same frequency bands and are in the LEOP path. All operators of satellites in that path will be provided with an emergency phone number where the licensee can be reached in the event that harmful interference occurs.

5. Grant of this authorization is without prejudice to any determination that the Commission may make regarding pending or future Intelsat License LLC, as debtor-in-possession applications.
6. Any action taken or expense incurred as a result of operations pursuant to this STA is solely at Intelsat License LLC, as debtor-in-possession’s risk.
7. Operations of this station during the period from expiration October 11, 2020, FCC IBFS File No. SES-STA-20200821-00899, to the grant of this STA was authorized pursuant to Section 1.62 of the Commission's rules, 47 C.F.R. § 1.62.
