- 1. Operations in the 13.77-13.78 GHz frequency band shall be limited to an e.i.r.p. density of no greater than 71 dBW in any 6 MHz band in accordance with Footnote US357 or else the 13.77-13.78 GHz band shall be excluded from operation.
