Request for Special Temporary Authority

Media Holdco, LP ("Transferor") and Scripps Media, LLC hereby request Special Temporary Authority ("STA") to allow consummation of a transfer of control application for **two transmit/receive earth stations** associated with the transfer of control of the ION Television Network ("ITN") and ION Media Network Inc.'s ("ION") full power television stations to Scripps Media, Inc. ("Scripps"), and the assignment of several full-power television licenses from Scripps to INYO Broadcast Holdings, LLC ("INYO") (the "Transaction"). ION, Scripps, and INYO intend to consummate the Transaction as early as December 31, 2020. Unfortunately, the transfer of control applications for the instant authorization will not be grantable on that date. The requested STA would permit Scripps to hold and operate the earth station authorizations on a temporary basis while the Commission processes the application described herein, and is necessary to permit expeditious consummation of the Transaction as early as December 31, 2020.

The Transaction

On October 13, 2020, ION, Scripps, and INYO filed applications with the Commission seeking approval of the transfer of control of 71 full-power television stations controlled by ION to Scripps and the assignment of 23 full-power television stations from Scripps to INYO. As described in the applications, the Transaction promotes the public interest by vastly increasing the availability of high quality and diverse free over-the-air programming content that competes directly with the services available via paid programming services. This increase in the supply of high-quality free content will also spur increased competition in the fast-evolving video programming marketplace. The Commission granted the applications on December 15, 2020.

Because the Transaction involves transfer of both the ION Network and each of its owned television stations, the Transaction also requires transfer of the other license assets used and useful in the operation of those properties. This includes a primary and a backup transmit/receive earth station used in the nationwide satellite distribution of ITN programming. These assets are crucial to the operation of both the ITN and the associated television stations.

Earth Station Authorizations for E150101 and E920199

ION is seeking the Commission's consent to the transfer of the authorizations for two transmit/receive earth stations, E920199, in Clearwater, Florida, and E150101, Shelby, Tennessee (the "Earth Station Authorizations"). Earth Station E920199 is a key element of the ITN's nationwide satellite distribution system. ION-affiliated stations in more than 70 markets across the United States depend on that facility to ensure that they receive ION Network programming. Earth Station E150101 is a backup facility for E920199 and handles distribution of ION Network programming during any disruptions in the operation of E920199.

Each of these earth stations is critical to the operation of the ITN. It is therefore essential that the authorizations for these earth stations transfer from ION to Scripps at the same time as the other assets involved in the Transaction.

Request for Special Temporary Authority

The application for transfer of both the Earth Station Authorizations was filed on December 9, 2020 and was placed on public notice on December 16, 2020. Thus, the application will not be eligible for grant by December 31, 2020 under normal Commission processing procedures. Grant of this request will allow the Parties to maintain uninterrupted operations of the ITN and its dozens of local television station affiliates across the country.

To permit the parties to consummate the Transaction, ION and Scripps request that Scripps be granted special temporary authority to hold and operate the transmit/receive earth stations pursuant to the existing authorizations beginning on December 31, 2020 and ending on the date Scripps is permitted to consummate its acquisition of the licenses for those facilities. The parties expect that an STA through January 31, 2020 should be sufficient. Grant of the requested STA would serve the public interest by permitting completion of a transaction that the Commission has already deemed to serve the public interest. Granting Scripps authorization to operate these facilities under the current licenses will ensure uninterrupted service to ION television viewers across the country. In light of the high value of the interests that would be served by the requested authority and the very short duration of the request, ION and Scripps submit that the requested relief serves the public interest and should be granted.
