Re: Request for Special Temporary Authority

Riverside, California Earth Station E990551

Dear Ms. Dortch:

Intelsat License LLC, as debtor in possession ("Intelsat"), herein requests a grant of Special Temporary Authority ("STA")¹ for 60 days, commencing January 15, 2021, to use its Riverside, California C-band earth station (Call Sign E990551) to provide telemetry, tracking, and command ("TT&C") services for the Galaxy 30 satellite (S3016)² at its on-station location of 125.0° W.L. Galaxy 30 is currently drifting from 84.55° E.L. to 125.0° W.L. and Intelsat expects the satellite to arrive on-station in mid-January. Intelsat will be filing a modification application to support the proposed TT&C operations.

The proposed Galaxy 30 TT&C operations will be performed at the following frequencies: 6421.75 MHz and 6424.25 MHz in the uplink, and 4197.5 MHz and 4198.5 MHz in the downlink. The operations will be consistent with Intelsat's coordination agreements for the 125.0° W.L. orbital location.

In further support of this request, Intelsat herewith attaches Exhibit A, which contains a coordination report. In the extremely unlikely event that harmful interference should occur due to transmissions to or from its earth station, Intelsat will take all reasonable steps to eliminate the interference.
