Re: Request for Extension of Special Temporary Authority Hagerstown, Maryland Earth Station E000296

Intelsat License LLC, as debtor in possession ("Intelsat"), herein requests an additional 30 days of Special Temporary Authority ("STA")¹ previously granted to Intelsat² to use its Hagerstown, Maryland C-band earth station, Call Sign E000296, to provide telemetry, tracking, and command ("TT&C") during in-orbit testing ("IOT") and drift services (collectively, the "TT&C Services") for the Star One D2 satellite. ³ Star One D2 was launched on July 30, 2021. Intelsat expects the TT&C Services to last an additional 30 days.

The Star One D2 operations will continue to be performed at the following frequencies: 6418.5 MHz and 6424.5 MHz in the uplink; and 4196.5 MHz and 4197.7 MHz in the downlink. The TT&C Services operations are being coordinated with all operators of satellites that use the same frequency bands and are in the drift path.⁴ All operators of satellites in these paths will be provided with an emergency phone number where the licensee can be reached in the event that harmful interference occurs.

In further support of this request, Intelsat incorporates by reference Exhibits A and B of its original request,⁵ which contain waiver requests and a coordination report. In the extremely unlikely event that harmful interference should occur due to transmissions to or from its earth station, Intelsat will take all reasonable steps to eliminate the interference.

Finally, Intelsat clarifies that during the Star One D2 mission, Maxar will serve as the mission manager. Maxar will build and send the commands to the Intelsat antenna, which will process and execute the commands. Telemetry received by Intelsat will be forwarded to Maxar. Intelsat will perform the ranging sessions by sending a tone to the spacecraft periodically. Intelsat will remain in control of the baseband unit, RF equipment, and antenna.

Grant of this STA extension request will allow Intelsat to help launch the Star One D2 satellite. This will help provide services at the 70° W.L. location and thereby promotes the public interest.
