Special Temporary Authority ("STA")

Intelsat License LLC, as debtor in possession (Intelsat License LLC) is granted authority to operate its fixed earth station in Hagerstown, Maryland at 39°35'54.6" N, 77°45'33.0" W (Call Sign KA258) under STA for 30 days, commencing November 26, 2021, to provide telemetry, tracking, and command ("TT&C") for Intelsat 26, a U.K.-licensed satellite, to support the decommissioning of the satellite in its disposal orbit. Operations are authorized on the following frequencies: 12748.5 MHz and 12749.5 MHz in the downlink; and 14499.0 MHz in the uplink.

Operations are authorized under the following conditions:

1. Operations shall be within the earth station's authorized emission designation to conduct TT&C and shall not exceed corresponding authorized power.
2. All operations under this grant of STA shall be on an unprotected and nonharmful interference basis. Intelsat shall not cause harmful interference to, and shall not claim protection from interference, any other lawfully operating radio communication system.
3. In the event of any harmful interference Intelsat License LLC shall cease operations immediately upon notification of such interference, and shall immediately inform the Commission, in writing, of such an event.

5. Grant of this STA is without prejudice to any determination that the Commission may make regarding pending or future Intelsat License LLC applications.
6. Intelsat License LLC shall, at all times, take all necessary measures to ensure that the STA operation at this earth station does not create potential exposure of humans to radiofrequency radiation in excess of the FCC exposure limits defined in 47 CFR § 1.1307(b) and 1.1310. Physical measures must be taken to ensure compliance with limits for both occupational/controlled exposure and for general population/uncontrolled exposure, as defined in these rule sections. Compliance can be accomplished in most cases by appropriate restrictions, such as fencing. Requirements for restrictions can be determined by predictions based on calculations, modeling, or by field measurements. The FCC's OET Bulletin 65 (available on-line at [www.fcc.gov/oet/rfsafety](http://www.fcc.gov/oet/rfsafety)) provides information on predicting exposure levels and on methods for ensuring compliance, including the use of warning and alerting signs and protective equipment for workers.
7. Any action taken, or expense incurred as a result of operations pursuant to this STA is solely at Intelsat License LLC's risk.

This grant is issued pursuant to Section 0.261 of the Commission's rules on delegated authority, 47 CFR § 0.261, and is effective upon release.
