Re: Request for Special Temporary Authority
Hagerstown, Maryland Earth Station KA275

Dear Ms. Dortch:

Intelsat License LLC ("Intelsat") herein requests 30 days of Special Temporary Authority ("STA"),¹ commencing June 28, 2022, to use its Hagerstown, Maryland C-band earth station, Call Sign KA275, to provide launch and early orbit phase ("LEOP") services for the SES-22 satellite, Call Sign S3138.² SES-22 is expected to launch on June 28, 2022.³ Intelsat expects the LEOP period to last approximately 10 days.⁴

The SES-22 operations will be performed at the following frequencies: 6421.0 MHz and 6423.5 MHz in the uplink; and 4197.3 MHz and 4199.5 MHz in the downlink. The LEOP operations will be coordinated with all operators of satellites that use the same frequency bands and are in the LEOP path.⁵ All operators of satellites in that path will be provided with an emergency phone number where the licensee can be reached in the event that harmful interference occurs. In the extremely unlikely event that harmful interference should occur due to transmissions to or from its earth station, Intelsat will take all reasonable steps to eliminate the interference.

³ The satellite's in-orbit testing will occur at 142° W.L., and its final location will be 135° W.L.

⁵ Thales Alenia Space ("Thales"), the manager of the SES-22 mission, will handle the coordination.

Finally, Intelsat clarifies that during the SES-22 LEOP mission, Thales will serve as the mission manager. Thales will build and send the commands to the Intelsat antenna, which will process and execute the commands. Telemetry received by Intelsat will be forwarded to Thales. Intelsat will perform the ranging sessions by sending a tone to the spacecraft periodically. Intelsat will remain in control of the baseband unit, RF equipment, and antenna.

Grant of this STA request will allow Intelsat to help launch the SES-22 satellite. This will help provide services at the 135° W.L. location and thereby promotes the public interest.
